



AIBS Conference Accredited Membership Promotion

Promotional Terms & Conditions

1. Promoter

The promoter is the Australian Institute of Building Surveyors (AIBS) ABN [53 004 540 836]

2. Promotion Overview

AIBS is offering eligible attendees of selected AIBS conferences a complimentary first-year AIBS membership ("Promotion"). The Promotion applies to membership fees for the first year of accredited membership only and does not include accreditation assessment fees, accreditation approval, or any professional certification outcome.

3. Promotion Period

1. The Promotion applies to eligible attendees of participating AIBS conferences held during the 2026 conference program.
2. Eligible conferences are those identified by AIBS as participating in the Promotion and published on the relevant AIBS conference or promotion webpage.
3. Eligible applicants must submit their membership application using the applicable promotional coupon code within three (3) months of the relevant conference date unless otherwise determined by AIBS. Expired coupon codes will not be accepted.

4. Eligibility

To be eligible for the Promotion, an applicant must:

1. be either:
 - a non-member of AIBS; or
 - a former AIBS member whose membership lapsed before 1 July 2021; and
2. purchase a two-day conference ticket at the non-member registration rate for an eligible AIBS conference; and
3. attend the relevant, eligible AIBS conference (attendance will be recorded by AIBS as advised at the conference); and;
4. submit a valid accreditation membership application during the promotion period.

The following individuals are not eligible:

- current AIBS members; and
- former accredited members whose membership started after 1 July 2021.



Eligibility is determined solely by AIBS based on its membership records and conference registration and attendance records.

5. Conference Attendance Requirement

Applicants must have attended the relevant conference in order to qualify for the Promotion. AIBS reserves the right to verify conference attendance and eligibility before applying any promotional benefit.

Where attendance or eligibility cannot be verified, AIBS may refuse the promotional benefit.

6. What the Promotion Includes

The Promotion provides an eligible applicant with:

- a waiver of the first-year AIBS accredited membership fee only.

No charge applies for the first year where the Promotion is successfully applied and the membership application is approved. Membership category eligibility and classification will be determined by AIBS in accordance with its standard membership criteria and accreditation requirements.

7. What the Promotion Does Not Include

The Promotion does not include:

1. accreditation assessment fees;
2. accreditation approval;
3. guaranteed membership approval. Accredited membership applicants must satisfy the criteria for accreditation, at an appropriate level according to their qualifications and experience, at the time of their application. Applications must be assessed by the National Accreditation Panel under the AIBS National Accreditation Scheme.
4. any fees payable after the first membership year.
5. conference registration fees;
6. webinar fees;
7. CPD event fees;
8. training course fees; or
9. any other fees for AIBS products, services, events, webinars, subscriptions, or activities unless expressly stated otherwise.

All membership applications remain subject to standard AIBS assessment and approval requirements. Participation in this promotion does not guarantee accreditation, accredited membership approval, or any particular accreditation outcome. Applicants must satisfy all applicable accreditation criteria and requirements, and all applications are subject to assessment and determination by the AIBS National Accreditation Panel under the [AIBS National Accreditation Scheme](#).



8. Membership Applications

Applicants must complete the applicable AIBS membership application process and enter the promotional coupon code in the designated application field.

Coupon codes:

- are single use only;
- are non-transferable;
- must not be sold, shared, reproduced, or otherwise distributed; and
- may only be used by the eligible recipient.

AIBS reserves the right to invalidate coupon codes used contrary to these Terms & Conditions or where misuse, fraud, or unauthorised activity is identified by AIBS, acting reasonably.

9. Membership Renewals

Following the complimentary first membership year, standard annual membership renewal fees and conditions will apply.

AIBS will issue renewal notices in accordance with its standard membership processes.

10. Privacy & Communications

By participating in this Promotion, applicants acknowledge that AIBS may collect, store, and use their personal information for the purposes of:

- administering this Promotion;
- verifying conference attendance and eligibility;
- processing membership applications;
- managing membership records; and
- communicating with applicants regarding their application, membership status, or promotion-related matters.

Applicants may also receive marketing communications from AIBS, where permitted by law. Recipients may opt out of marketing communications at any time using the unsubscribe facility included in AIBS communications.

AIBS may disclose personal information to third-party service providers engaged to support membership administration, event management, or system operations where reasonably necessary for administering this Promotion.

11. AIBS Rights & Promotion Administration

AIBS reserves the right, where reasonably necessary, to:

- verify applicant eligibility;
- refuse applications that do not meet eligibility requirements;



- invalidate coupon codes issued in error;
- investigate suspected misuse or fraudulent activity;
- amend these Terms & Conditions; or
- suspend or cancel the Promotion.

AIBS decisions regarding eligibility and administration of the Promotion will be made reasonably and in accordance with these Terms & Conditions. AIBS reserves the right to withdraw, amend, or substitute the Promotion where reasonably necessary due to operational, technical, administrative, or other circumstances beyond its reasonable control.

12. Limitation of Liability

To the maximum extent permitted by law, AIBS is not responsible for:

- technical failures;
- system errors;
- lost or delayed communications;
- unauthorised use of coupon codes; or
- circumstances outside AIBS' reasonable control that may affect the administration of the Promotion.

Nothing in these Terms & Conditions excludes any rights or remedies that cannot lawfully be excluded under Australian law, including where caused by events outside AIBS' reasonable control.

13. Governing Law

These Terms & Conditions are governed by the laws of New South Wales, Australia. Applicants submit to the non-exclusive jurisdiction of the courts of New South Wales, Australia.

14. Acceptance of Terms

15. Severability

If any provision of these Terms & Conditions is found to be unlawful, void, or unenforceable, that provision will be severed and the remaining provisions will continue in full force and effect.
